Information Collected

Information collected from online service users occurs during league/team registration, online rostering, online purchases and surveys conducted on our website.

During information collection for an organization's registration, you may be asked for your organization's name / address / phone / email address / website, the organization's accident and liability insurance company name and policy number, the primary organization's contact's name / address / phone / email address and credit card information for payment.

During information collection for league information or tournament team rostering and affidavit creation, you may be asked for:

- Your team(s) parent's first name / last name / address / phone / email
- The corresponding child(s) information including their first name / middle name / last name / date of birth / gender
- Your team(s) coaches' first name / last name / date of birth / address / phone / email.

During website store checkout, you may be asked for your name, address, email address, phone number and credit card information for payment.

During website online surveys, you may be asked for your name, address, email address, phone number to be contacted for more information about the survey answers you supplied.

Use of our website for general information may be accessed anonymously.

How Is Your Information Used

Information collected during use of our online experience may be used in the following ways:

- Online experience personalization
- Post league/team registration contact for information relay purposes by your PONY organization, local PONY field director or PONY Headquarters
- Online experience improvement
- Confirmation of residence location for zone, region and league boundary purposes
- Creation of league team affidavit, tournament team or Travel/Select team affidavit.
- To process financial transaction from registration of our services or purchase of our products
- To send periodic informational emails about our service or services of our partners

How Is Your Information Protected

Information security is important to us. We work hard to keep your information safe when you enter personal information on our website during your online experience.

Our registration vendor uses commercial grade encryption for the transmission of data and commercial grade firewalls to protect their servers. Their servers and networks are certified by VISA/MasterCard and scans are run to verify security standards are met.

The registration vendor takes every precaution to protect our user's information. All our information is protected both online and offline. All transactions, where sensitive information is collected, are protected by the highest levels of security and encryption available.

When our registration forms ask users to enter sensitive information (such as credit card number), that information is encrypted and is protected with 256 bit security. While on a secure page, such as our registration forms, the lock icon in modern web browsers becomes locked, as opposed to un-locked, or open, when you are just “surfing”.

Our online store vendor is certified Level 1 PCI DSS compliant.

Use Of Cookies

Our online store uses cookies to remember items in your online shopping cart.

COPPA Compliance

Our registration vendor sites that COPPA was enacted to protect children, especially children under the age of 13, using the Internet. Our online vendor supports this act and hopes that all parents work with their children to help them understand safety on the Internet.
